Introduction

Goal: Improved wellbeing of children through strengthening the formal and informal Child protection systems in Tharaka Nithi County.

Outcomes:

1.Increased responsiveness of the formal and informal child protection systems

Formal child protection systems often involve GOK agencies responsible for child welfare. Increased responsiveness in this context means these agencies can swiftly and efficiently investigate reports of abuse or neglect and take appropriate actions to protect the child.

Informal systems -community-based networks, neighbors, friends, and family members who play a role in observing and reporting concerns about a child's well-being. Increased responsiveness in this context means that community members are aware of child protection issues, are willing to intervene, and can connect with formal systems when needed.

2.Increased participation of children in their own protection

Project Summary

- ❖ This project aims at improving protection outcomes for children and their families through supporting the establishment of a safe and secure environment free from gender-based violence (GBV) and child sexual exploitation and abuse in Tharaka Nithi County, Kenya.
- ❖ The increasing use of the internet and digital technologies has exposed children to new and complex online risks, such as cyberbullying, grooming, and exposure to inappropriate content.
- Combating OCSEA and strengthening victim support requires comprehensive and sustained actions from everyone who is responsible to tackle this growing problem, including government duty-bearers, law enforcement agencies, justice and social support service professionals, internet providers, communities, teachers, and caregivers.
- SBV affects most of the families in Kenya and this has negative impact to children. The major type of GBV reported are domestic violence, sexual abuse and harmful cultural practices such as early marriage.

Project Strategies

- Enhancing awareness raising and sensitization about the role of different stakeholders in the protection of children,
- Educating community members, parents, teachers, and children themselves on recognizing signs of abuse, reporting incidents, and promoting a culture of respect.
- Advocacy and policy influence, with particular focus on coordination of child protection issues and actors at various levels (family, community, Sub-County, County and National levels). The focus will be on strengthening child protection systems, enhancing education and awareness, empowering families and communities to ensure the safety, well-being, and rights of all children in the county.

The project will support 5 police stations with child protection desks in Tharaka Nithi county and ensure they are functional and manned. These help desks will be fully fitted with furniture. This will involve desks, chairs, Printers, files, cabinets, desktops

Support County Children's Assembly meetings: The County Children's assembly is a platform for children to participate in governance and decision-making at the county level. It is part of the Kenya Children's Assembly, which is a national initiative that aims to promote the rights and welfare of children in Kenya

PARTNERS AND THEIR ROLES

- ❖ Department of Children Services at Sub-Counties level: Provide technical assistance and support through training and supervision. Also Work with the VCOs and other community-based child protection champions.
- Ministry of Health and Gender Based Violence and Recovery Centers (GBVPRC): provide technical skills and treatment opportunities for abused and conduct follow up.
- Community Based Child Protection teams: Constitute the community-based child protection system that will coordinate prevention and response activities of child protection and linking to the formal child protection mechanism.
- Local NGOs, CBOs and faith- based organizations: will be peers to partner and network in CP issues. They will also participate in the CAC and LCAC and are therefore a resource on CBCP.
- Charitable Children Institutions (CCIs): will be critical collaborators for vulnerable survivors of child abuse.
- Teachers: trained as Child protection champions and oversee the implementation of child protection activities at school level.
- Children: the target group and they will also participate in their own protection; the children's club leaders will specifically play the role of CP champions and will sensitize other children. This will ensure sustainability of child protection efforts at the various community levels.
- ChildFund: Provide finances and technical support during Project implementation and monitoring.
